The Chair called the meeting to order at 6:10 p.m. and introduced the three-member Call to Order and panel of speakers from the Chevron Corporation: Ricardo Reis Veiga, Managing Counsel for Latin America, Renae Magaw, Senior Research Toxicologist, and Charlie Stewart, Manager for Public Affairs.

A three-member panel of speakers from the Chevron Corporation – Ricardo Reis Veiga, Managing Counsel for Latin America; Renae Magaw, Senior Research Toxicologist; and Charlie Stewart, Manager for Public Affairs - presented to the Committee Chevron's side of the controversy in Ecuador that resulted from Texaco's operations in the Amazonian rainforest from the 1970s through the early '90s, the remediation of well-sites and pits (which has been complicated by the Ecuadorian state-run oil company's continued operations there) and subsequent alleged negative health effects. The confidential presentation specifically addressed Chevron's fulfillment of its legal obligations in Ecuador, and the company's toxicological research findings with respect to soil and water samples collected in and near remediated sites. The presentation was followed by a period of Q&A between Committee and panel members.
