The Committee recalled earlier discussions concerning the fact that certain shareholder proposals on banking issues may come up for review this proxy season. In those discussions, the Committee noted that "banking issues" were not explicitly covered in the Committee's 2006-2007 Annual Agenda; at the time, the Committee agreed to evaluate any such proposals as they became available to determine if they were appropriate for formal review and recommendation. Thus, the Committee appraised an upcoming proxy to Wells Fargo & Company to "report on fair housing lending policy/record" to determine whether the Committee should formally review this proposal and formulate a recommendation to the Trustees. The Committee agreed that the proposal (and any similar proposals) appeared appropriate for formal review, and believed that the issues covered by the proposal would be of interest and concern to the Columbia community. The Wells Fargo proposal is on the proxy review agenda for the next Committee meeting.

Discussion on Banking Proposals

The Committee agreed to meet next on April 10, 2007 at 6:00 pm in the Burden Room (206 Low Library) for proxy review. Staff for the Committee confirmed that a panel of speakers from Chevron Corporation would address the Committee on Tuesday, April 17, 2007 at 6:00 p.m. in the Trustees Room (212 Low Library).
