The Chair called the meeting to order at 6:25 p.m.

In executive session, the Committee discussed the draft communication to Chevron Corporation. The Committee suggested revisions to the draft document, agreed upon the addressee(s) and individuals to be copied on the letter, and further agreed that the Chair of the Committee and the Coordinator for Socially Responsible Investing would make all final revisions as necessary.

The Committee confirmed the recommendation of the Sudan divestment subcommittee to remove Rolls-Royce Group PLC from Columbia's Sudan divestment list. On April 19, 2007, Rolls-Royce announced that it will sign no new contracts in Sudan and will begin to withdraw existing operations from that country due to the humanitarian crisis in Darfur. The Committee carefully considered this development, and, on the recommendation of the Sudan divestment subcommittee, agreed to present a formal recommendation to the Trustees Subcommittee on Shareholder Responsibility to remove Rolls-Royce from Columbia's divestment list. While the Committee established its Sudan monitoring process to occur annually during the fall semester, in this case, the developments at Rolls-Royce came to public light outside of that timeframe and the Committee felt it was appropriate to respond promptly with a recommendation.

The Committee turned its attention to the draft 2006-2007 Interim Annual Report, which would be submitted to the University Senate at the time of the Chair's report to the Senate at its spring plenary session on Friday, May 4, 2007. Committee members suggested brief revisions and agreed to make any further suggestions over email by noon on Thursday, May 3, 2007.
